Chevron Oil Spill:

On Tuesday, Feb. 9, 2021, the Richmond, CA community experienced an **environmental disaster** when Chevron spilled **600 gallons of petroleum** into the Bay, poisoning the Point Richmond shoreline. Chevron provided no emergency alert or warning to the community. CBO APEN organizers spent hours calling family, friends, neighbors, and members to warn them about the oil spill and to avoid Point Richmond and surrounding beaches. This area is where some in the SOMAH communities we serve live, work, go to school, and fish. This emphasizes California's urgent need to create clean air and a healthy environment where all people can thrive.

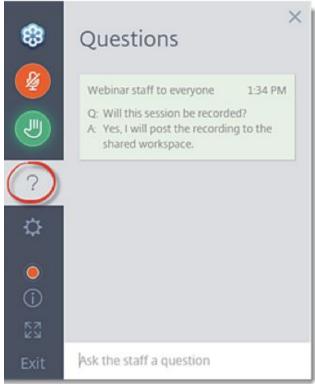
Take action and join **APEN** on Feb. 23 and demand that Chevron be held accountable and enforce the strongest refinery rule to reduce their toxic pollution.

We encourage everyone to reflect on the history and contribution of the Black community not just during the month of February but every day.



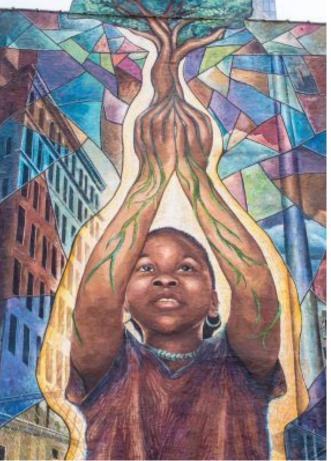

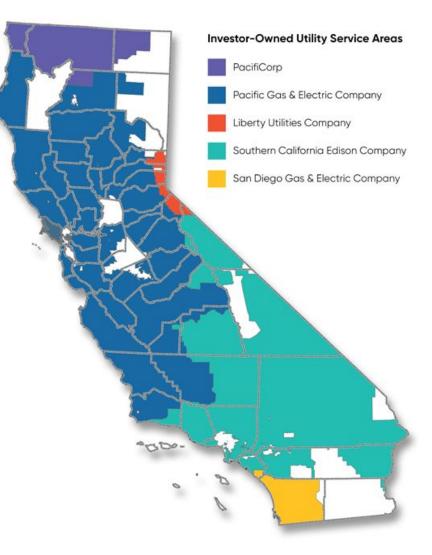

Session 1: SOMAH Program Update Application Breakdown



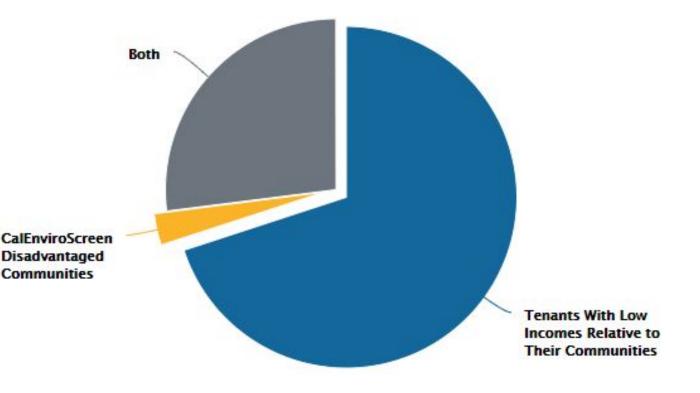

Session 1: SOMAH Program Update Where We Are Today



- 30% of SOMAH's active applications are located in Disadvantaged Communities (DACs)*
- Tenants are slated to receive ~88% of the electricity generated from SOMAH installations



*DACs are defined as "the top 25% scoring areas from <u>CalEnviroScreen</u> along with other areas with high amounts of pollution and low populations" SB 535

- AL 114 Filed in June 2020 requesting edits for substantive changes and minor revisions
 - Application Pipeline Management (Lottery)
 - Required Notification for Early Job Trainee Termination
 - System Changes Affecting Incentive Amounts
- Substitute sheets filed on February 5 to integrate AL 114 Handbook (Fourth edition) with approved Progress Payment Handbook (Third edition)
- Progress Payments Pathway More in next session

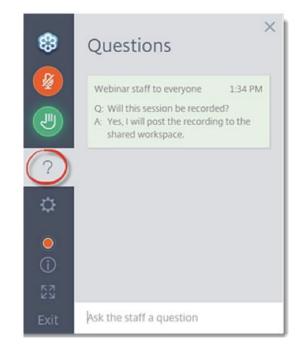

Session 2: Progress Payment Pathway **Background**



- COVID-19 pandemic has significantly impacted contractor business models and access to financing
- Proposal: Break the incentive payment into progress payments to help alleviate cash flow issues



Session 2: Progress Payment Pathway Why Progress Payments?



- Assist projects affected by cash crunch due to COVID-19
- 2. Break down financing barriers faced by smaller, more diverse contractors



Session 2: Progress Payment Pathway **PA Consultation Process**



- Engaged with contractors, IOUs, CBOs, financiers, etc. to understand options
- Balancing responsiveness to needs, against safeguarding program funds was a key consideration
- Resulted in a two-payment progress payment pathway:
 - **60%** of the reserved incentive payment paid after the project has been verified to be mechanically complete
 - Remaining incentive after the Incentive Claim Approval

Session 2: Progress Payment Pathway Approval & Implementation



- CSE Advice Letter-118 submitted on September 18, 2020 and approved by Energy Division on December 21, 2020
- Next steps for implementation:
 - → Launch progress payments **landing page** on CalSOMAH.org
 - → Hold a participant **webinar** on February 25, 2021
 - → Finalize application documents and **update PowerClerk**
 - \rightarrow Update **incentive contracts** with each IOU
- Launch progress payments (Date TBD)

Session 2: Progress Payment Pathway **Project Eligibility**



- Eligible applicants can opt-in to the Progress Payment Pathway (PPP) after Proof of Project Milestone (PPM) approval is received
- PPP eligibility prerequisites
 - System is fully installed ("mechanically complete")
 - Incentive Claim Package Deadline is no less than 4 months from PPP submission date

Session 2: Progress Payment Pathway Program Requirements



- Application requirements
 - Progress Payment Request Form
 - Affidavit Ensuring Tenant Education
 - Optional/upon request: supporting documentations for virtual walkthrough
 - Electronic Payment Setup Form (as applicable)
- Projects will complete a live virtual walkthrough via a video call to verify system installation

Session 2: Progress Payment Pathway Program Reporting



- Reporting on Progress Payments will rollout after launch
- Updates to Working Dataset on CaliforniaDGstats
 - Opt-in indication and progress payment amount
- The Semiannual Progress Report (SAPR) will include Progress Payments stats moving forward
